

In the following we refer to Regulation (EC) No. 1907/2006 (REACH). This statement is available in German and English.
In case of interpretation difficulties, the German text shall be the authoritative one.

Background

The new European legislation REACH entered into force on 1st June 2007. It concerns the Registration, Evaluation, Authorization and Restriction of chemicals. Affected by REACH are substances as such, in preparations and in articles if they are intended to be released under normal conditions of use.

After 1st June 2008, only those substances which have been pre-registered with the European Chemicals Agency between 1st June and 1st December 2008, which are considered as registered or which are exempted from REACH can be imported into or produced in the EU. Substances imported or produced below 1 ton/year per importer/producer are exempted from registration.

Furthermore, if substances present on the candidate list for authorization (candidates to be included in Annex XIV: List of substances subject to authorization) are contained in a product at a rate of > 0.1% by weight, their presence has to be communicated downstream.

Articles

The products provided by AirLoc are articles that do not contain substances that are intended to be released. Therefore, the substances contained in AirLoc products are not subject to registration.

Substances/Preparations

The substances contained in the following AirLoc products (Preparations) have been pre-registered by the manufacturer or importer in the EU. An additional pre-registration for re-importation into the EU is not necessary due to the low amount of substances delivered into the EU. • **Currently no products**

All products delivered by AirLoc are in compliance with the REACH regulation and can be delivered without restriction.

Candidate list

As a producer of articles we are obliged to communicate to our customers the presence of substances that are listed on the candidate list for authorization (candidates to be included in Annex XIV: List of substances subject to authorization) above 0.1% per weight in our articles.

Since 2018-06-27 the element lead (Pb, CAS: 7439-92-1) has been included into the candidate list. **According to Article 33 of the REACH regulation we inform you that more than 0.1% in mass of lead (Pb) is contained in our lead-alloyed products.** Lead is not released during normal use of system components, but may be released in case of improper use or disposal.

According to our current knowledge, we confirm that all other products delivered by AirLoc are free of or contain less than 0.1% per weight of the substances on the candidate list. We are continuously monitoring the candidate list for new substances. Should substances on the candidate list be contained in our products in the future, we will inform you immediately.
